#### ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely dangerous and is believed to be spread from person-to-person contact. As a result, federal, state and local governments and health agencies recommend established guidelines to reduce the risk of spreading the virus. These include requiring social distancing and, in many locations, prohibiting the congregation of large groups of people (Wyoming Health Order #2, effective July 16<sup>th</sup>-31<sup>st</sup> limits events to gatherings of 50 people or less, with exceptions to up to 250 for certain events, subject to conditions listed below).

The Teton Climbers' Coalition (TCC) has put in place preventative measures to reduce the spread of COVID-19. However, TCC cannot guarantee that you will not come into contact with, or become infected with, coronavirus. Your mere physical presence at could increase your risk of contracting the disease.

Notwithstanding the risk of infection, I wish to voluntarily participate in this Adopt-A-Crag event and state as follows:

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk I may be exposed to or infected by COVID-19 by attending this event. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of TCC members, agents, and representatives, whether a COVID-19 infection occurs before, during or after attendance.
